## Contestant Release

In consideration for the opportunity to compete in the Rodeo, Contestant agrees as follows:

1. Contestant, for himself or herself, his or her spouse, legal representatives, heirs and assigns, hereby releases, waives and discharges Releasees, their officers, directors, members, agents and employees from all liability to the Contestant, his or her spouse, legal representatives, shareholders, heirs, successors and assigns, from any and all loss or damage sustained by the Contestant in connection with the Rodeo.
2. By executing this Release, contestant expressly acknowledges that under Kansas law there is no liability for an injury to or the death of a participant in domestic animals activities resulting from the inherent risks of domestic animal activities and is assuming the risk of participating in such a domestic animal activity. Contestants enter and participate at their own risk entirely.
3. Contestant hereby agrees not to institute judicial proceedings against Releasees to attempt to recover damages resulting from personal injury or property damage to self or others.
4. Contestant understands and agrees that no part of this Release is or shall be construed as an admission of liability on the part of Releasees arising out of any such personal injury or property damage.
5. Contestant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Kansas, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
